

VAS 6572A/2 MOBILE EXTRACTION SYSTEM FOR ALUMINIUM AND CFK DUST

Mobile industrial vacuum cleaner with spark trap of filter class M for the collection of explosive chips and grinding dust generated during the typical machining of aluminium body parts.

Due to the attached spark trap including a 5 M cooling section, the industrial vacuum cleaner complies with DGVU regulation 109-001 and is suitable for grinding, fettling and polishing aluminium. It is safety tested according to the provisions of EN 60335-2-69 and Annex AA+CC and is suitable for use in Zone 22.

- For vacuuming dry, combustible dust hazardous to health: dust class H
- For collection of any dust with all exposure limits*, including dust hazardous to health - with return of clean air to the working area.
- Dust class H (including dust classes L and M)
